AN ACT TO ADD A NEW § 3116 TO CHAPTER 3, TITLE 27, GUAM ADMINISTRATIVE RULES AND REGULATIONS, RELATIVE TO THE ADOPTION OF THE PEACE OFFICER STANDARDS AND TRAINING (POST) COMMISSION'S PHYSICAL FITNESS QUALIFICATIONS TEST (PFQT) STANDARDS.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new § 3116 is *added* to Chapter 3 of Title 27, Guam
3 Administrative Rules and Regulations, to read:

4 **“§ 3116. Establishment of Physical Fitness Qualification Test Standards**
5 **Pursuant to Public Law 34-49.**

6 In accordance with § 3105 of this Chapter, and pursuant to the
7 provisions of Public Law 34-49, the Peace Officer Standards and Training
8 (POST) Commission’s Physical Fitness Qualification Test (PFQT)Standards
9 for Category 1 and 2 peace officers shall comply with the test standards
10 indicated in the following appendices with respect to the government of Guam
11 entity indicated:

- 12 1. Appendix A – Guam Police Department
- 13 2. Appendix B – Guam Department of Education
- 14 3. Appendix C – Customs and Quarantine Agency
- 15 4. Appendix D – Port Authority of Guam

- 1 5. Appendix E – Guam International Airport Authority
- 2 6. Appendix F – Guam Fire Department
- 3 7. Appendix G – Department of Agriculture
- 4 8. Appendix H – Department of Corrections
- 5 9. Appendix I – Judiciary of Guam
- 6 10. Appendix J – Department of Parks and Recreation
- 7 11. Appendix K – Office of the Attorney General
- 8 12. Appendix L – Department of Youth Affairs”

9 **Section 2. Effective Date.** This Act *shall* be effective upon enactment.

10 **Section 3. Severability.** If any provision of this Act or its application to
11 any person or circumstance is found to be invalid or contrary to law, such invalidity
12 *shall not* affect other provisions or applications of this Act that can be given effect
13 without the invalid provisions or application, and to this end the provisions of this
14 Act are severable.
