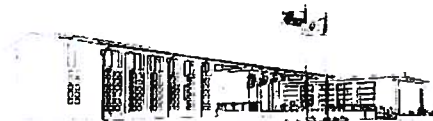





**AN ACT TO AMEND § 24103(b) OF ARTICLE 1,
CHAPTER 24, TITLE 11, GUAM CODE ANNOTATED,
RELATIVE TO CLARIFYING THE ADDITIONAL TAX
LEVY ON REAL PROPERTY IMPROVEMENTS
VALUED AT ONE MILLION DOLLARS (\$1,000,000) OR
MORE.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 24103(b) of Article 1, Chapter 24, Title 11, Guam Code
3 Annotated, is *amended* to read:

4 “(b) In addition to the levy in Subsection (a), there is hereby levied
5 on improvements on all land property in Guam with a value of One Million
6 Dollars (\$1,000,000) or more a yearly tax at the rate of seven eighteenths

1 percent (7/18%) of the value thereon. Such tax *shall* be assessed and collected
2 in the manner prescribed in this Chapter. All proceeds derived by the
3 government under any provision of this Chapter *shall* be deposited in the
4 Guam Educational Facilities Fund.”
