WHEREAS, on November 29, 2017, the Guam Supreme Court issued its opinion in *In Re: Request of I Maga'lahen Guáhan Eddie Baza Calvo Relative to the Interpretation and Application of Organic Act Section 1423b and What Constitutes the Affirmative Vote of the Members of I Liheslaturan Guáhan*, 2017 Guam 14, declaring Section 1.02(d)(4) of the Standing Rules of the 34th Guam Legislature as invalid and void; now therefore, be it

RESOLVED, that *I Mina'Trentai Kuáttro Na Liheslaturan Guáhan* amends Section 1.02(d)(4) of the Standing Rules of the 34th Guam Legislature to read:

“(4) Votes Required. ~~Unless otherwise required by the laws of Guam or under these Rules, a~~ Any action(s) which can be taken by *I Liheslaturan Guáhan* requires an affirmative vote of eight (8) Members; provided however that a bill that receives the

affirmative vote of a majority of the members present and voting shall be deemed to have passed even if that number is less than eight (8).”; and be it further

RESOLVED, that the Speaker certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of the same be thereafter transmitted to the all Members of *I Mina 'Trentai Kuáttro Na Liheslaturan Guáhan*.
