1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF**

3 **WHEREAS,** *I Liheslaturan Guáhan*, through the Committee on Rules, has not
4 yet adopted a Resolution authorizing expenditures for the current Fiscal Year; and

5 **WHEREAS,** members of the Committee on Rules were just presented with an
6 already prepared resolution disposing of the funds of *I Liheslaturan Guáhan* for the
7 remaining Fiscal Year, without discussion and input from the Committee on Rules
8 members, nor a public meeting concerning the expenditures; and

9 **WHEREAS,** the members of the Committee on Rules were informed that if the
10 proposed resolution were not passed immediately that *I Liheslaturan Guáhan* would
11 need to shut down by Monday, April 3, 2017; and

12 **WHEREAS,** an abrupt approval of a budget, without an open meeting called by
13 the Committee on Rules, and presented at the last minute, would be a disservice to the
14 members of *I Liheslaturan Guáhan* as well as to the employees, attaches, vendors, and
15 most especially, the public; now, therefore be it
