**Footnotes:** 1/ The proposed legislation is for the Route 14B (Ypao Road) Reconstruction and Widening Project, which is part of the Islandwide Road Improvement Plan that is being funded by U.S. Department of Transportation, Federal Highway Administration (FHWA). Costs are in connection with land condemnation based on appraisals of the property. The amount of \$89,000 is determined for the fee simple interest taken in Lot 2143-6R/W, Municipality of Tamuning, Guam, and \$267,400 for fee simple interest taken in Lot 2143-1-6-R/W and Lot 2143-1-5G, Municipality of Tamuning, Guam.
