The Bureau requests that Bill No. 97-34 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 97-34 seeks to amend Sections 1 and 2 of P.L. 33-192 relative to an additional option for egress sizing in the international fire code and the international building code. The bill also adds a new subsection to section 202 and a new subsection 308.6 to section 308, both of the 2009 International Fire Code adopted by Guam.

The proposed amendments are administrative in nature and would not fiscally impact the appropriations for the Guam Fire Department (GFD) in FY 2017. Reference the attached memorandum from GFD regarding Bill 97-34 (LS).
