Hafa Adai! Senator Biscoe Lee:

The Bureau requests that Bill No. 399-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 399-35 is an act to add a new § 1903(a)(7) and a new § 19406 of Article 4, Chapter 19, Title 10 of the Guam Code Annotated. The Bill adds measures for fiscal responsibility and accountability where upon renewal of an original declaration of a state of public health emergency, all applicable procurement laws and regulations shall revert to full applicability and enforceability.

The proposed amendments are administrative in nature and would not fiscally impact the appropriations of Government of Guam.
