Hafa adai! Senator Biscoe Lee:

The Bureau requests that Bill No. 134-35 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 134-35 (COR) seeks to do the following: (1) add a new Chapter 39B to Division 3 of Title 7, Guam Code Annotated (GCA), relative to the Custody and Visitation of nonparents; (2) repeal subsection (G) of §8404 of Chapter 8, Division 1 of Title 19 GCA, relative to the current statute on grandparental rights of visitation; (3) amend subsection (H)(5) of §8404, Chapter 8, Division 1 of Title 19 GCA, relative to the consideration of grandparents in providing child-care for their grandchildren; and (4) citing this act as the "Uniform Nonparent Custody and Visitation Act of 2019".

The intent of the proposed measure is administrative in nature and, as such, poses no fiscal impact on any funds of the Government of Guam.

However, it should be noted that the legislation incorrectly cites subsections (G) and (H)(5) both of §8404, Chapter 8, Division 1 of Title 19 GCA. These subsection/subitem designations were amended in 2016 to adhere to the Compiler's codification and alpha-numeric scheme. Based on the foregoing, the subsections should cite (a)(7) and (a)(8)(E) both of §8404, Chapter 8, Division 1 of Title 19 GCA, respectfully.
