**AN ACT TO AMEND SECTION 70127 OF TITLE 11 GUAM  
CODE ANNOTATED, RELATIVE TO ALIEN LABOR.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 Section 1. Section 70127 of Title 11 Guam Code Annotated is hereby amended  
3 to read as follows:

4 §70127. Alien Labor. Any person holding a license under the provisions of this  
5 Division is required to certify to the Director of Revenue and Taxation the intended  
6 departure of any alien working for such person at least fourteen (14) days prior to such  
7 departure date. The License Board shall have the power to suspend or revoke any  
8 license and levy a fine of One Thousand Dollars (\$1000) for each alien worker not  
9 reported when, after formal hearing, it finds that any person has intentionally or  
10 knowingly failed to certify the intended departure of any alien labor as provided by  
11 this section. The fines collected under this section shall be deposited into the Better  
12 Public Service Fund.
