1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Transfer of Property.** Administrative jurisdiction over the
3 Inarajan Community Center is hereby transferred to the Inarajan Mayor, provided
4 that the Mayor uses the Community Center for civic and community purposes.
5 Such purposes may include, but are not limited to, a community and recreational
6 center; a learning center; museum; fishermen's and farmer's cooperative.

7 **Section 2. Item (8) of §40113 of Chapter 40, Title 5 of the Guam Code**
8 **Annotated is hereby amended to read as follows:**

9 “(8) The Mayor of Inarajan is responsible for Recreation Area I,
10 Recreation Area II, [~~and~~] the Malojloj Recreation Area and the Inarajan
11 Community Center;”
