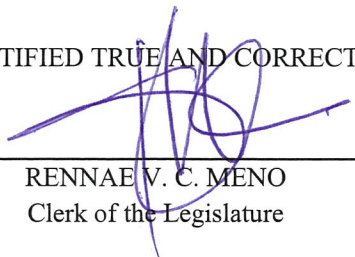

**AN ACT TO *AMEND* SECTION 8 OF CHAPTER XI,
PUBLIC LAW 34-116; AND TO APPROPRIATE TWO
HUNDRED NINETY-EIGHT THOUSAND FIVE
HUNDRED THIRTY-SIX DOLLARS (\$298,536) FROM
THE GENERAL FUND TO THE GUAM ELECTION
COMMISSION FOR EXPENDITURES RELATED TO
THE 2018 PRIMARY AND GENERAL ELECTIONS.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Section 8 of Chapter XI, Public Law 34-116 is hereby *amended*
to read:

“Section 8. Guam Retirement Security Plan. The sum of ~~Five Hundred
Thousand Dollars (\$500,000)~~ Two Hundred One Thousand Four Hundred Sixty-
four Dollars (\$201,464) is hereby appropriated from the General Fund to fund the
Guam Retirement Security Plan established by Public Law 33-186.”

Section 2. Appropriation to the Guam Election Commission. The sum
of Two Hundred Ninety-eight Thousand Five Hundred Thirty-six Dollars
(\$298,536) is appropriated from the General Fund in Fiscal Year 2019 to the Guam
Election Commission for the sole purpose of paying expenditures related to the
2018 Primary and General Elections. The sum of One Hundred Nine Thousand Six
Hundred Fifty Dollars **(\$109,650)** is authorized from the appropriation in this

1 Section to pay prior year obligations of the Guam Election Commission for 2018
2 Primary Election expenditures.

3 **Section 3. Effective Date.** This Act *shall* become effective upon
4 enactment.

5 **Section 4. Severability.** If any provision of this Act or its application to
6 any person or circumstance is found to be invalid or contrary to law, such
7 invalidity *shall not* affect other provisions or applications of this Act that can be
8 given effect without the invalid provision or application, and to this end the
9 provisions of this Act are severable.
