The confirmation hearing of Dr John J Rivera to serve as a member of the Guam Housing and Urban Renewal Authority Board of Commissioners for five years from May 3rd 2021 to May 2nd 2026.

For the record my name is Ray Sanchez Topazna and I currently serve as the Executive Director of GHURA, I am here this morning actually it's afternoon because I'm in Seattle to testify in full support of Dr. John J. Rivera to serve on the GHURA Board of Commissioners. Dr. John J. Rivera, Nominee, Guam Housing and Urban Renewal Authority Board of Commissioners: *Hafa Adai* Honorable Senators Thank you to the Chair Senator San Agustin thank you to Senator Shelton who's hosting this right now Senator Ada, Senator Nelson I see Senator Brown and Senator Taitague thank you so much. For the record my name is John Rivera and I am honored to be here this morning first I would like to express my gratitude for my nomination by Governor Lou, Lieutenant Governor Josh and the support of Director Topasna Deputy Director Liz and the rest of the GHURA family that I've met. I'm an executive coach consultant and collegiate professor my forte is in human capital innovation through agile leadership transformation and organizational development specializing in emotional intelligence personality type and strategic talent capacity building. I have a PHD in Organization and Management with a specialization in leadership. I hold two Master's Degrees an NPA in a Professional MBA and an Executive certificate in public policy from the Harvard Kennedy School and numerous professional credentials post nominal designation for the work that I've done. I've been acknowledged with the pontifical order of Knighthood by Pope Benedict XVI. I have served in several capacities in other non-governmental boards to include President, Officer Roles, Founding Member Roles, Founding Board Officer Roles I was recognized as who's who in the Government of Guam 40 years and under and 50 under 40 emerging leaders in the Government in Guam named the 2020 UOG Triton faculty of the year among the Inaugural Speakers of Ted *Hagatna* and recently completed emerging leaders State colleges and Universities where I was selected as one of 35 in the Nation currently I'm a tenured Associate Professor of Public Administration with the University of Guam School of Business in Public Administration. Anthony Ada: Thank you, Madam Chair, again good morning, Dr. Rivera and I have known Dr. Rivera for many, many years and him reading off his resume is just such an it's so impressive but I think he said it best that he's still the average CHamoru, and I think that Dr. Rivera will fit in anywhere you place him and I hope Director Topasna you know you got him for this time, but it is my hope that the Administration Governor Leon Guerrero and Lieutenant Governor Josh Tenorio would actually find a place where you would be very instrumental in forging forward the and helping forge the lives of those that we serve and like I it's just don't have words because I've known you for so many years and you've always been

that humble person that just works to do the best that you can to impact the most lives that you can and ensuring that the end result is always something that we can all be proud of I have absolutely no questions for you Dr. Rivera you have my full support and you have my vote and Madam Chair I hope that we'll be able to get Dr. Rivera on to the next session so that we can vote on his confirmation get him on that board so he can he can start working and I know he's already working you know making decisions or even giving suggestions and recommendations and how to make thing better but I think that we really need to move forward with this confirmation then thank you Dr. Rivera for answering Governor Leon Guerrero's call and Lieutenant Governor Josh Tenorio is called to serve on the GHURA board and I love to work with you in the future and see how we can make things better for our people again thank you Dr. Rivera thank you Madam.

Senator Amanda L. Shelton: *Si Yu'os Ma'åse* Senator Ada, Senator Taitague.

Senator Telo T. Taitague: One second, *Hafa Adai* Dr. Rivera thank you so much for stepping up to the plate I mean very impressive of course your resume and I know it's not going to end as far as all the other educational stuff that you're going to go after having two Master's Degree I'm sure you're going to go after something else but why I mean with your resume why GHURA I mean you can basically go anywhere and with your expertise why would you want to serve on GHURA?

Dr. John J. Rivera, Nominee, Guam Housing and Urban Renewal Authority Board of Commissioners: Thank You Senator for the question GHURA specifically at this moment because that's where I'm called to serve, I really don't pick usually the places that I serve you know in leadership they say that many are called right and few are chosen and I was asked to step up to the plate here at GHURA and so it is my honor and my privilege to be able to serve in any capacity that I am ask whenever I am able to

Senator Telo T. Taitague: So, are you willing to serve this? capacity if it's only for 50 instead of 250?

Dr. John J. Rivera, Nominee, Guam Housing and Urban Renewal Authority Board of Commissioners: I'm willing to serve in this capacity regardless of the payment right I think that the payment for me personally right is not the motivating factor this is what motivates me and I'm happy to do so regardless. Senator Joanne Brown: Thank you very much Madam Chair certainly, appreciate the interest of Dr. Rivera and wanting to serve on the GHURA Board he definitely without question brings a very, very impressive credentials and certainly could take his pick probably of any border commission the Government of Guam but I did want to ask him with regards to GHURA what direction would he like to contribute to either improve or you know they're talking about re-branding GHURA in terms of their public image but in terms of him from a policy standpoint and sitting in the GHURA Board does he have any particular issue or direction he would like to see shifted or improved during his tenure with the board.

Dr. John J. Rivera, Nominee, Guam Housing and Urban Renewal Authority Board of Commissioners: Thank you, Senator, for that question you know to be fair I honestly don't know exactly where I believe that GHURA should be I haven't gotten enough ground time with them in order to make that determination but i do say that this in the conversations that I've had and from what I've heard this I think in time not only for GHURA but for Guam itself and so if GHURA can be a vehicle or an opportunity to better the lives of the people or an opportunity to do things better or be an example then for sure that's where we're going

Senator Joanne Brown: Well, I certainly appreciate that Dr. Rivera I mean to have someone of your credentials I don't think we say that lightly I mean we'd love to see more people you know especially of our own local people that have been as accomplished as you are coming forth literally to do on top of the long list of things that you already do to keep you busy and being a person of faith coming into this process I think at a time when more of our people want to see better direction and leadership in government you know having the power is one thing but using it responsibly and as you mentioned I mean doing it to improve the lives of our people ultimately is what we would like to see all our public officials regardless of what capacity that we serve and certainly in your role because I don't doubt you will be confirmed unanimously to this position we just want to see that continuously by work that you do and what you contribute what you pass on to your students certainly creating a whole another up-and-coming generation that we very much want to see a sense of personal responsibility within their community because that's what we need it's not going to be a select few we're going to need a bigger broader community that has that sense of personal responsibility that not only do we have the opportunity to benefit but more importantly we have a responsibility to give back give back to our community and certainly god blesses us with certain talents um it's not for our own use but it's to better it's to better the lives of all our people because we have many challenges now and certainly will have challenges ahead so I certainly appreciate your interest you know the fact like I said you have so much on your plate already that you're willing to step forth and contribute in this capacity but don't doubt in the future to hear more of the remarkable work that you're doing so Congratulations ahead of time because I'm sure you will be confirmed and

happy holidays again Thank you for your continued public service thank you very much Madam Chair for the opportunity to ask Dr. Rivera a short question Thank You.

Senator Amanda L. Shelton: Senator Brown thank you very much and as Senator Ada mentioned we will do our best to move this confirmation forward in the next session and I too would like to give my support to Dr. Rivera knowing him from my time at the University of Guam as my professor I know that he is certainly qualified and I'm very happy Dr. Rivera that you're willing to do this job and take on more on your already very full plate we're very thankful for your willingness to serve in this capacity and we look forward to the contributions that you will be making I think there's one more individual coming online to testify for you so we'll give him a minute to sign on just take one minute we have Mr. Sunny Perez who is going to be testifying for Dr. John Rivera please turn on your camera sir Okay maybe there are some technical difficulties if he comes online then we will allow him to testify okay if not if anyone else would like to submit testimony for the confirmation of Dr. John J. Rivera to the committee we will be receiving testimony for the next few days for any additional information to this public hearing and you may submit those testimonies to the mail room at the Guam Legislature or through email at senatorjoesanaugustine@gmail.com I believe I just saw Mr. Perez sign on so Mr. Perez please turn on your camera and you may begin your testimony. Sonny Perez, Architectural/Engineering Manager, Guam Housing and Urban Renewal Authority: Thank you so much sure my name is Sunny Perez I am the Architectural Engineering Manager here at GHURA and have been I thought it was I'm so sorry

Senator Amanda L. Shelton: We can hear you now, we can hear you now, you're following delay

Sonny Perez, Architectural/Engineering Manager, Guam Housing and Urban Renewal Authority: Okay yeah apologize it says my internet says it's unstable thank you so much my name is Sunny Perez

Senator Amanda L. Shelton: I think i don't have your YouTube or your live stream playing in the background if you can shut that off and then.

Sonny Perez, Architectural/Engineering Manager, Guam Housing and Urban Renewal Authority: Yes, I will I apologize (inaudible) oh, i thought I'm so sorry.

Sonny Perez, Architectural/Engineering Manager, Guam Housing and Urban Renewal Authority: There you go.

Senator Amanda L. Shelton: Okay, please begin, no problem

Sonny Perez, Architectural/Engineering Manager, Guam Housing and Urban Renewal Authority: Yes, I would like to testify for support for Dr. John known to john for quite a long time since my PMBA years and of course I'd like to tell a funny story if I indulge you for a few minutes how back in 2011 I was taking the PMBA for doctor with Dr. Colfax i was one of the PMBA students there and at the time I guess that was almost 10 years ago and Dr. John looks young while he was he looked younger back then and so there was this little shrimpy squirty student looking person coming in with a ponytail and I said okay he's supposed to teach me something new and lo and behold it was Dr. John and I said okay I'll be patient I'll be patient with what with what he may be able to teach me but i kind of know it all well lo and behold I was very pleasantly surprised that I did learn a lot and through my years at the University of Guam I was also the Chief Plant Facilities Officer there at the University of Guam


