**AN ACT TO AUTHORIZE THE GOVERNOR OF GUAM
TO TEMPORARILY APPOINT A LEGAL OFFICER ON
BEHALF OF THE GOVERNMENT OF GUAM.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. The Governor or governing board or commission may appoint a Legal Officer for the following agencies of the government of Guam for a 90 day period to advise during all phases of the procurement process and other legal matters except for prosecution. Duties of the Attorney General to review and advise agencies relative to procurement pursuant to 5 GCA Ch. 5 are suspended for 90 days for the following agencies; provided that, contracts exceeding \$500,000 for those agencies shall continue to be reviewed and approved by the elected AG on behalf of the Government of Guam as to correctness of form and legality pursuant to 5 GCA §5150 regardless if the elected AG previously represented the Director in that procurement matter. All duties of the current elected Attorney General as prosecutor shall continue uninterrupted.
