AN ACT TO APPROPRIATE ONE MILLION FIVE HUNDRED SIXTY THREE THOUSAND SIX HUNDRED ONE DOLLARS AND FIFTY CENTS (\$1,563,601.50) **FISCAL YEAR** 2024 FROM **GENERAL FUND** REVENUES COLLECTED IN **EXCESS** THE ADOPTED LEVELS ENUMERATED IN PUBLIC LAW 37-42, AS *AMENDED*, FOR MERIT BONUS PAYMENTS OWED TO CURRENT AND FORMER EMPLOYEES OF THE GUAM MEMORIAL HOSPITAL AUTHORITY AND OTHER GOVERNMENT OF GUAM AGENCIES AND ENTITIES EARNED FROM FISCAL YEAR 2010 TO PRESENT.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. Public Law 37-42 (Budget Act
- 3 for Fiscal Year 2024) contained a provision that required all meritorious bonuses
- 4 owed to Government of Guam employees and retirees from FY 2010 to present be
- 5 paid by December 31, 2023. The provision required agencies to use funds from their
- 6 FY 2024 allocations to make the payments.
- 7 On April 23, 2024, the Director of the Department of Administration reported
- 8 that Merit Bonuses remaining to be paid to active and former employees from

1 various agencies amounted to Seven Hundred Three Thousand Seven Hundred

2 Seventy Two Dollars (\$703,772.00). The report, however, did not account for the

merit bonuses earned by active and former employees of the Guam Memorial

4 Hospital Authority. See Attachment "A."

An inquiry with GMHA officials revealed that merit bonuses earned by the hospital's active and former employees between 2012 and 2020 amounted to Eight Hundred Fifty Nine Thousand Eight Hundred Twenty Nine Dollars and Fifty Cents (\$859,829.50). It was further revealed that GMHA had no funds to pay their current and former employees their earned bonuses and would be seeking assistance to satisfy the debt. See Attachment "B."

The employees of the Government of Guam who earned a meritorious pay for their outstanding and exemplary performance have been made to wait far too long, some for well over ten years, for a payment they deserved. While the government had failed to meet the statutorily imposed deadline to make all payments, it is the intent of *I Liheslaturan Guåhan* to provide the necessary funding (as reported by the Department of Administration and the Guam Memorial Hospital Authority) to finally pay what is due to the deserving employees.

**Section 2. Appropriation. (a)** Notwithstanding any other provision of law, the sum of Eight Hundred Fifty Nine Thousand Eight Hundred Twenty Nine Thousand Dollars and Fifty Cents (\$859,829.50) is hereby appropriated from Fiscal Year 2024 General Fund revenues collected in excess of the adopted levels enumerated in Public Law 37-42, as amended, to the Guam Memorial Hospital Authority for the payment of merit bonuses earned by active and former employees during the period of 2012 to 2020. This appropriation shall be available until fully expended.

**(b)** Notwithstanding any other provision of law, the sum of Seven Hundred Three Thousand Seven Hundred Seventy Two Dollars (\$703,772.00) is hereby

- 1 appropriated from Fiscal Year 2024 General Fund revenues collected in excess of
- 2 the adopted levels enumerated in Public Law 37-42, as amended, to the Department
- 3 of Administration for the payment of merit bonuses earned by active and former
- 4 employees of Executive Branch Line Agencies that lacked funding to satisfy the
- 5 payments as per an April 23, 2024 report provided by the Director of the Department
- 6 of Administration. This appropriation shall be available until fully expended.
- 7 **Section 3. Severability.** If any provision of this Act or its application to any person
- 8 or circumstance is found to be invalid or inorganic, such invalidity shall not affect
- 9 other provisions or applications of this Act that can be given effect without the
- 10 invalid provision or application, and to this end the provisions of this Act are
- 11 severable.

12 **Section 4. Effective Date.** This Act shall be effective upon enactment.
