1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, on October 14, 2023, former United States District Court Judge,
4 John Sablan Unpingco passed away on Guam; and

5 **WHEREAS**, Title 1 of the Guam Code Annotated, Section 419 allows the State
6 Funeral for any citizen who, in the opinion of the Committee on Rules of the
7 Legislature, has displayed exemplary service for the island and the people of Guam, if
8 the family of the deceased so agrees; and

9 **WHEREAS**, Section 1 further provides that expenses for a State Funeral shall
10 be paid by the government of Guam. Expenses for State Funerals shall be paid out of
11 the operations fund of the Guam Legislature which shall be periodically reimbursed by
12 appropriations from the General Fund; now therefore, be it

13 **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan* does hereby,
14 on behalf of the people of Guam, authorize the 37th Guam Legislature to honor the late

1 John Sablan Unpingco, former United States district court of Guam judge with a state
2 funeral; and be it further

3 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
4 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
5 the same be thereafter transmitted to all the members of *I Mina'trentai Siette na*
6 *Liheslaturan Guåhan*; to Mr. Joseph R. San Agustin, Executive Director of *I*
7 *Liheslaturan Guåhan*, and to Ms. Agnes Cruz, Chief Fiscal Officer of *I Liheslaturan*
8 *Guåhan*.
