1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***
2 ***MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, Section 7.04(c) of Rule VII of *I Mina'trentai Siette Na Liheslaturan*
4 *Guåhan Otden Areklamento* (the Thirty-Seventh Guam Legislature Standing Rules)
5 allows the Standing Rules to be amended by a Rules Resolution adopted by the
6 affirmative vote of at least seven (7) members of the Committee on Rules; now
7 therefore, be it


8 **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan* does hereby
9 *amend* Section 14.09(w) of Rule XIV, Part E, Thirty-Seventh Guam Legislature
10 Standing Rules, to read:

11 “(w) **Expiration of Appointments.** All appointments to positions in *I*
12 *Mina'trentai Siette Na Liheslaturan Guåhan* shall automatically expire on
13 January 6, ~~2024~~2025. All lump sum payments due at the expiration of
14 appointment, as opposed to resignation or other termination, *shall* be paid on, or
15 within a reasonable time, after January ~~52~~, ~~2024~~2025.”; and be it further

1 **RESOLVED**, that the Legislative Counsel is allowed to renumber and make
2 technical corrections consistent with the intent of this Resolution; and be it further

3 **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules
4 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of
5 the same be thereafter transmitted to the Members of *I Mina'trentai Siette Na*
6 *Liheslaturan Guáhan*; to Attorney Darleen E. Hiton, Legislative Counsel; to Joaquin P.
7 Taitague, Substitute Clerk of the Legislature; to Mr. Edward S. Pocaigue, Jr. Sergeant
8 at Arms of the Legislature; to Agnes A. Cruz, Chief Fiscal Officer of the Legislature;
9 and to Mr. Joseph R. San Agustin, Executive Director of the Legislature.
