



1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** for sixty (60) years, since 1964, the Guam Little League has
4 brought the game of baseball to the thousands of children and youth throughout the
5 island; and

6 **WHEREAS,** the Guam Little League is a registered non-profit organization and
7 operates on funding obtained through contributions and donations from the local
8 community and business sector. The program administers various fundraising events
9 and financial projects to sustain its operation in bringing baseball to the masses of youth;
10 and

11 **WHEREAS,** Guam Little League works to fulfill their mission to “firmly
12 implant in the children of the community the ideals of good sportsmanship, honesty,
13 loyalty, courage and respect for authority, so that they may be well adjusted, stronger

1 and happier children and grow to be good, decent, healthy and trustworthy citizens”;

3 **WHEREAS**, the Guam Little League Senior Division Tournament Team
4 participated and competed at the Asia Pacific/Middle East Regional, held from March
5 28, 2024 to April 4, 2024, in Auckland, New Zealand; and

6 **WHEREAS**, the team and staff accompanied by many Guam supporters,
7 traveled to root-on and witness the accomplishments and success of Team Guam in the
8 Regional Tournament;

9 **WHEREAS**, the talented members of the 2024 Guam Senior Little League
10 Tournament Team includes: Evan R.L. Acosta, Patrick S.C. Alvarez, Derrin M. Q.
11 Gumataotao, Theano M. Jones, Ty James S.A. Leon Guerrero, Ryan M.A. Lizama,
12 Rayn M.C. Rios, Ethan J.C. Santiago, Trace J. Taijeron, Javier C. Taimanglo, Co'en E.
13 Villanueva, and Kaiden J.B. Weakley; and

14 **WHEREAS**, the 2024 Guam Tournament Team Coaching Staff includes: Kevin

21 **WHEREAS**, as a result of the Asia Pacific/Middle East Regional Tournament
22 Championship, the 2024 Guam Little League Tournament Team will represent the
23 region at the 2024 Senior Little League World Series in Easley, South Carolina from
24 July 27, 2024 to August 5, 2024; now therefore, be it
