1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***  
2        ***MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS**, the Committee on Rules of *I Mina'trentai Siette Na Liheslaturan*  
4        *Guåhan*, constituted as the policy-making body of *I Liheslaturan Guåhan*, has oversight  
5        of resolutions and bills relating to the business, budget, design, and activities of *I*  
6        *Liheslaturan Guåhan*, and shall prescribe all policies governing the administration and  
7        operation of the Central Office of *I Liheslaturan Guåhan*, including, but not limited to,  
8        staff organization, function, personñel requirements, and rates of compensation; and


9        **WHEREAS**, monies from the Central Operations Lapse Fund may be expended  
10       as directed by a resolution from the Committee on Rules of *I Mina'trentai Siette Na*  
11       *Liheslaturan Guåhan* adopted by no less than seven (7) of its members, in accordance  
12       with Section 15.10 of the Standing Rules of *I Mina'trentai Siette Na Liheslaturan*  
13       *Guåhan*; and

1           **WHEREAS**, Senior Citizens Month is celebrated during the month of May every  
2 year and *I Liheslaturan Guåhan* desires to honor Guam’s senior citizens at a banquet  
3 during the Annual Senior Citizens Day; now therefore, be it

4           **RESOLVED**, that the Committee on Rules of *I Mina'trentai Siette Na*  
5 *Liheslaturan Guåhan* does hereby authorize the expenditure in the amount of up to  
6 Twenty-Six Thousand Dollars (**\$26,000**) from the Central Operations Lapse Fund for  
7 the purpose of making payments to vendors to conduct the Annual Senior Citizen’s Day  
8 Luncheon; and be it further

9           **RESOLVED**, that the Speaker and the Chairperson of the Committee on Rules  
10 certify, and the Legislative Secretary attest to, the adoption hereof, and that copies of  
11 the same be thereafter transmitted to the Senators of *I Mina'trentai Siette Na*  
12 *Liheslaturan Guåhan*; to Ms. Agnes A. Cruz, Chief Financial Officer of *I Liheslaturan*  
13 *Guåhan*; and to Mr. Joseph R. San Agustin, Executive Director of *I Liheslaturan*  
14 *Guåhan*.
