3 **WHEREAS**, it is the sense of *I Liheslaturan Guåhan* to recognize the life and
4 accomplishments of those distinguished citizens of this great island, and it is the custom
5 of *I Liheslaturan Guåhan* to commend those public servants who have devoted
6 themselves faithfully serving in the best interests of this community and the needs of its
7 residents; and

8 **WHEREAS**, Domingo Z. Molo began his years of service to the people of Guam
9 in July 2001 as a Maintenance Specialist at Guam Telephone Authority before
10 becoming a Maintenance Worker in February 2005 at the Department of Military

11 distinguished service and commitment to the people of Guam and has earned awards
12 including the GIAA 5-Year Service Award, GIAA 10-Year Service Award, and the
