



3 **WHEREAS,** Arsenio Fontalba Espino was born to Arsenio Dayao Espino and
4 Celerina Fontalba Espino; and

5 **WHEREAS,** Arsenio is husband to Diana and father to Darence, Shaira, and
6 Shaileen; and

7 **WHEREAS,** Arsenio began his employment with the Department of Corrections
8 (DOC) on July 12, 1993; and

9 **WHEREAS,** Arsenio was assigned as the Safety Officer for DOC for several
10 years, ensuring that every building had a Fire Evacuation Plan, working fire
11 extinguishers, and a fire sprinkler system; and

12 **WHEREAS,** Arsenio was the Unit Manager for the Post 7 Administrative
13 Segregation Unit and Training Commander; and

1 **WHEREAS**, Arsenio was assigned to the Hagåtña Detention Facility as the
2 Hagåtña Detention Commander and was certified as a SORT (Special Operations
3 Response Team) member; and

4 **WHEREAS**, Arsenio is a retired member of the United States Air Force
5 Reserves; and

6 **WHEREAS**, Arsenio was a valued, hardworking member of the Department of
7 Corrections, contributing to all department functions, supporting luncheons at the
8 Hagåtña Detention Facility as well as at the Adult Correctional Facility and during
9 Labor Day, donating his own time and resources to make repairs at both facilities; and

10 **WHEREAS**, Arsenio’s sense of professionalism, energy, and graciousness
11 enriched all of those fortunate to know and work with him; now therefore, be it
