3 **WHEREAS, *I Liheslaturan Guåhan* takes great pride in recognizing the lives**
4 **and achievements of distinguished individuals who have dedicated themselves to**
5 **serving the best interests of our island community and meeting the needs of our people;**

7 **WHEREAS, in keeping with its long-standing traditions of honoring exemplary**
8 **service, *I Liheslaturan Guåhan* is proud to commend and celebrate the Honorable**
9 **Mayor Dale E. Alvarez; and**

10 **WHEREAS, the Honorable Dale Eugene Alvarez was born on August 29, 1949,**
11 **in the village of *Santa Rita-Sumai*, Guam, to the late †Isabel Aquiningoc and the late**
12 **†Jerry T. Alvarez; he is the second oldest of twelve (12) children, and alongside his**
13 **wife, the former Helen Sablan Perez, he has raised a loving family of six (6) children;**

1 **WHEREAS**, Mayor Alvarez pursued his early education at J.P. Torres
2 Elementary School, Agat Junior High School, and graduated in 1967 from George
3 Washington High School. Furthering his vocational training, he attended the Manpower
4 Development Training Act in 1970 and completed an apprenticeship program with the
5 U.S. Navy Public Works Center, graduating as a Boilermaker journeyman in 1974; and

6 **WHEREAS**, Mayor Alvarez is a Vietnam War veteran, having served honorably
7 in the United States (U.S.) Navy from 1967 to 1969. He continued his career with the
8 U.S. Navy, working as a sandblaster at the Ship Repair Facility in Guam in 1970, and
9 later held various key positions at the Public Works Center (PWC), including Shop
10 Planner, Maintenance Supervisor I, and Quality Assurance Evaluator, before retiring in
11 2002. From 2003 to 2008, he further contributed as a Quality Assurance Evaluator and
12 Performance Assessment Representative for defense contractor Alutiiq, LLC; and

13 **WHEREAS**, Mayor Alvarez has served as Mayor of the Municipality of *Santa*
14 *Rita-Sumai* since 2009, demonstrating steadfast leadership, fostering community
15 development, and advocating for the welfare of his constituents; and

16 **WHEREAS**, Mayor Alvarez has also been deeply involved in community
17 activities, including serving as Vice President of the Guam Fishermen's Cooperative, a
18 member of the Western Pacific Fisheries Advisory Panel, and holding various roles in
19 Guam's youth and amateur baseball leagues as a coach, manager, and advocate. He is
20 the founder and past president of the Big Daddy Softball Association, further
21 exemplifying his commitment to fostering sportsmanship and teamwork among Guam's
22 youth and adults; and

23 **WHEREAS**, Mayor Alvarez's lifelong dedication to the betterment of the
24 Municipality of *Santa Rita-Sumai* and the island of Guam is an inspiration to all,
25 showcasing a legacy of service, leadership, and unwavering commitment to his
26 community; now, therefore, be it
