1           **BE IT RESOLVED BY *I MINA'TRENTAI SIETTE NA LIHESLATURAN***  
2 ***GUÅHAN*:**

3           **WHEREAS**, Customs Officer II Kevin S. Fejeran resides in the village of Yona,  
4 with his supportive and loving common in law wife Alicia Lim and their children:  
5 Mathew, Blake, Kaitlyn, and Alexis, his family who continue to be a steadfast source  
6 of support throughout his life and career; and

7           **WHEREAS**, Customs Officer II Kevin S. Fejeran, a dedicated public servant of  
8 the Government of Guam, is retiring after thirty (30) years of distinguished service, with  
9 almost eleven (11) of those years devoted to the Guam Customs & Quarantine Agency  
10 (CQA), through his unwavering commitment, safeguarding the interests of the people

1 of Guam, playing an instrumental role in securing the island's social, economic,  
2 environmental, agricultural, and public health through his enforcement of Customs  
3 Laws and Regulations; and

4 **WHEREAS**, in 1994 his career in the Government of Guam began as an  
5 Auxiliary Worker with the Guam Police Department, providing support to the  
6 operations of the department. In 1997 he accepted a new position at the Guam Memorial  
7 Hospital Authority as an Emergency Room Technician, assisting with patient care,  
8 reporting and recording patient information, logistics, supplies, and equipment  
9 maintenance; and

10 **WHEREAS**, his service to all is not limited to our island, her people. In 2004 he  
11 courageously enlisted in the Guam Army National Guard serving eight (8) years and  
12 upon completion of his commitment he honorably discharged in 2014; and

13 **WHEREAS**, in 2013 Customs Officer II Kevin S. Fejeran joined the ranks of  
14 CQA as a Cadet Trainee with the 11th CQA Officer Training Academy, graduating with  
15 his peers in 2014, rising in ranks of Customs Officer I and II; and

16 **WHEREAS**, throughout his tenure, Customs Officer II Kevin S. Fejeran was  
17 assigned to CQA's Inspection & Control Division at the Guam International Air  
18 Terminal, Air Cargo Facility, Guam Main Postal Facility, Andersen Air Force Base and  
19 Maritime sections, where he was instrumental in facilitating trade, travel and commerce.  
20 Conducting his last assignment was with the Special Enforcement Division's, Maritime  
21 Contraband Enforcement Team, where he participated in investigations and operations  
22 that successfully apprehended persons evading customs entry and declarations  
23 processes through illegal arrivals around Guam's coastline; and

24 **WHEREAS**, Customs Officer II Kevin S. Fejeran, is recognized by his peers  
25 and superiors as a highly valued member of the agency as he was effective in the  
26 enforcement of laws and regulations, while maintaining fairness, diligence, and a  
27 commitment to justice; and

1           **WHEREAS**, Customs Officer II Kevin S. Fejeran has not only contributed to the  
2 day-to-day operations of the agency but has also been a mentor, role model, and leader  
3 within the customs workforce, inspiring fellow officers, and civilian staff through his  
4 work ethic, dedication, and sense of duty; and

5           **WHERAS**, dedication to his work and his unwavering commitment to serving  
6 the people of Guam is a testament to his professionalism and personal integrity to which  
7 he will always be honored for; and

8           **WHEREAS**, it is only fitting that Customs Officer II Kevin S. Fejeran be  
9 recognized for his lifetime of service, and as a mark of respect for his exemplary  
10 contributions, be conferred the honorary rank of Captain in recognition of his dedication  
11 and commitment to the safety and welfare of Guam’s people; now therefore, be it

13 on behalf of the people of Guam, recognize and congratulate Customs Officer II Kevin
