1        **BE IT RESOLVED BY *I MINA'TRENTAI SIETTE NA***  
2 ***LIHESLATURAN GUÅHAN*:**

3        **WHEREAS**, The AGA National invites currently enrolled undergraduate and  
4 graduate university students to participate in a virtual Government Finance Case  
5 Challenge. Student teams will have three weeks to analyze data from an AGA-  
6 specified U.S. state, city, or county government and develop a Citizen-Centric  
7 Report (CCR). Submissions will be evaluated by a panel of government finance  
8 experts, with finalists advancing to the final round to present their findings via video;  
9 and

10        **WHEREAS**, Dr. Doreen T. Crisostomo-Muña, Professor of Accounting at  
11 the University of Guam (UOG), formed a three-member student team from her Fall  
12 2024 Government Accounting class, which included UOG students Albin Tinoso,  
13 Katelyn Villa, and Ilaria Williams-Dueñas; and the UOG team entered the AGA  
14 competition, ultimately winning first place in the AGA's 2024 Government Finance  
15 Case Challenge Undergraduate Level; and

1           **WHEREAS**, the students from UOG conducted a comprehensive analysis of  
2 the state of Maine, highlighting critical aspects such as education, economic  
3 development and workforce training, health and human services (public health),  
4 transportation safety and development, and natural resources development and  
5 protection; they also examined the income and expenses, breaking down revenue  
6 and expense categories to offer a clear financial picture of the state; the analysis also  
7 addressed Maine’s economic outlook, and challenges the state faces; and

8           **WHEREAS**, the UOG team, along with their faculty advisor, was awarded  
9 One Thousand Five Hundred Dollars (\$1,500.00) per member, underscoring the  
10 team’s dedication and excellence in the field of government finance; now therefore,  
11 be it

13 on behalf of the people of Guam, recognize Dr. Doreen T. Crisostomo-Muña,
