

II. SUMMARY OF TESTIMONY AND DISCUSSION

The public hearing was called to order at 9:00 AM. Resolution No. 30-37 (COR) - RELATIVE TO SUPPORTING THE REPUBLIC OF CHINA (TAIWAN)'S PARTICIPATION AS OBSERVER AT THE WORLD HEALTH ORGANIZATION'S 76TH WORLD HEALTH ASSEMBLY AND TO REAFFIRM SUPPORT FOR THE REPUBLIC OF CHINA (TAIWAN)'S PARTICIPATION AS OBSERVER IN INTERNATIONAL ORGANIZATIONS. was the first item on the agenda.

Vice Speaker Tina Muña Barnes Chairperson: *Buenas yan Håfa Adai hamyo todus. Manana si Yu'os!* Many of God's blessings to all of you here this morning. The Committee on Human Resources, Hagåtña Revitalization Regional Affairs, Public Libraries, Telecommunications Technology, and Federal and Foreign Affairs is called to order at nine o'clock. It is now 9:00 AM That clock's a little bit fast for the record and in accordance with 5 GCA Chapter 8 subsection 8107 public hearing notices were sent on Thursday, February 23, 2023, adhering to the five-day notice and a second public notice on Tuesday, February 28, 2023, 48 hours prior.

Ladies and gentlemen, joining me here this morning is, Senator Tom Fisher, Senator Joanne Brown, and Senator, Taitague. good morning colleagues. Also, joining me is Senator Will Parkinson, I'd be remiss, ladies and gentlemen, if I didn't recognize, the family, of a dear colleague of mine, a late colleague of mine, the Terlaje Family, Senator Pedro Jose Pedro Terlaje, who's in the audience joining us today for one of the, action items on the agenda. *Manana si Yu'os* and welcome. Thank you for joining us.

Before we proceed with the discussion, ladies and gentlemen, I'd like to provide some general rules of conduct for all who are in attendance. The conduct of this hearing shall be as follows:

1. Those testifying will be recognized in the order of Sign-up on the sign-in sheet.
2. Written testimony may be read and submitted to the Committee. Please provide our Legislative staff with your written testimony for photocopying.

Ladies and gentlemen, I will shift around the agenda a little bit. In the audience, we have a representative from the, Taiwan economic, Cultural, office here. And he will be, we will be hearing a Resolution No. 30-37 (COR) we will put that at the top of the agenda in, in, respect to protocol and at this time, and I'd like to thank my colleague, who, afforded me the opportunity to help shift this agenda around.

This resolution, ladies and gentlemen, is 30-37 (COR). It is relative to supporting the Republic of China, (Taiwan's) participation as observer of the World Health Organization, 76 World Health Assembly, and to reaffirm support for the Republic of China Taiwan's participation as an observer in the international organizations.

And, before I, do my opening remarks, I will go ahead and invite Deputy Director, Vincent, Lu, to the table for his remarks. Please have a seat at the table and then I will provide my opening remarks and then yield to you. Please have a seat.

Ladies and gentlemen, this year we introduced this resolution, to reaffirm Guam's support of the Republic of China, (Taiwan), to participate, meaningfully at international stakeholder meetings. Hundreds of countries, parliamentarians, and legislatures in the US and around the world continue to stand behind Taiwan to participate at the World Health Assembly hosted by the World Health Organization, it's unfortunate that Taiwan still was not invited. Moreover, as global competitors with highly developed industries their insight at international meetings like the International Civil Aviation Organization, United Nation Framework Convention on Climate Change, and the International Criminal Police

Organization would be invaluable. In Guam's commitment to our fifty year Sister city relationship with Taipei and now our new Sister City relationship with Tao-Yuan and Tai-Jong. We hope to continue to support the Republic of China's participation at international stakeholder meetings. So that is my opening testimony, and again, at this time I will recognize Deputy Director Lu, to, share his, testimony today. Good morning.

Chi-Chang "Vincent" Lu - Deputy Director TECO in Guam: *Håfa Adai* everybody. Yes, I have a much pleasure and feel pretty honored to be present here, yes in the public hearing. Yes, to be held in, the Guam Legislature.

On the behalf of, Director Paul Chen of the Taipei Economic and Cultural office in Guam and the government of the Republic of China (Taiwan), I would like to express my most heartfelt appreciation, yes, to all of you yes, to members of the Guam Legislature and the people in the government of Guam, yeah, for your long lasting support and, in, in terms of the, the Taiwan's participation in the World Health Organization.

As far as I know, Taiwan has been excluded, yes, from the world, WHO, for several decades. But actually, Taiwan can make great contribution on the, pandemic prevention as well as the medical assistance in the international community. Taiwan can help and the Taiwan is helping, and I believe that, Taiwan, Taiwan's inclusion in WHO can contribute to the international community. Definitely.

And once again, thank you so much. Thank you so much Vice Speaker and our friends, all the senators present here in the public hearing, thank you so much. And, I believe that in the future, the, the friendly ties and the bilateral cooperation in the exchanges will continue to be further strengthened in the future once again, thank you.

Vice Speaker Tina Muña Barnes Chairperson: You're very welcome, Deputy Director Lu. At this time, I will open it, to my colleagues for any comments or questions and reference to this resolution. Senator Joe San Agustin, I'll recognize you at this time.

Senator Joe S. San Agustin: Thank you, Madam Chair. I'd just like to, thank you, Madam Chair for the authoring of the resolution, and I'm in full support of this. My father was a senator and a speaker for, with the Legislature for 20 years, and he's always been in full support of Taiwan. Thank you, Madam Chair.

Chi-Chang "Vincent" Lu, Deputy Director TECO in Guam: You're welcome. So glad to hear this, you're a friend of Taiwan.

Vice Speaker Tina Muña Barnes, Chairperson: You're very welcome. Senator San Agustin. Senator Will Parkinson, I will recognize you at this time.

Senator William A. Parkinson: Håfa Adai, sir, I don't have much to say. I remember going to Taiwan when I was a little kid and I'm always been a big fan and supporter of Taiwan and I look forward to supporting you on this resolution.

Chi-Chang "Vincent" Lu - Deputy Director, TECO in Guam: Thank you so much.

Vice Speaker Tina Muña Barnes Chairperson: Yeah. Thank you. Senator Parkinson. Senator Tom Fisher. Good morning. You're recognized.

Senator Thomas J. Fisher: Good morning, Madam Chair. Thank you very much and thank you, sir for being here. I am, I am proud to consider myself a friend of Taiwan, and I know that Taiwan is a great friend of Guam, and, the relationship between us is cherished. Taiwan is a beacon of democracy in the Western Pacific. We share the same values and we share the same, well, we share the same values in the, in a tradition of democratic participation in the government and so I commend Taiwan for that and again, I'm proud to be a friend of Taiwan. The only reservation I have, ma'am, is, because this addresses issues of foreign affairs, whether or not, the United States agrees with this and I don't know that you know that but.

Vice Speaker Tina Muña Barnes Chairperson: Yes, I do. They definitely, and have, the United States has been a very big ally and a partner to Taiwan for the last six, seven decades.

Senator Thomas J. Fisher: Okay. And they, and the United States, support observer status in these various organizations.

Vice Speaker Tina Muña Barnes Chairperson: Again, as part of the support and the efforts that we've been, working with, since 1974, they, we've been really big advocates and supporters, and so as Uncle Sam in those efforts. So thank you, Mr. Senator Fisher.

Senator Thomas J. Fisher: So thank you. And based on that representation, I too support the resolution.

Vice Speaker Tina Muña Barnes Chairperson: Thank you. Good morning, Senator Joanne, you're recognized at this time. Senator Taitague on a yield, good morning.

Senator Telo T. Taitague: Good morning, Madam Chair and thank you for the opportunity to be a part of something like this. It's, it's very important. I believe Taiwan, once left Guam for a while. They, the Director General's office, and decided to come back to Guam and came back to Guam in full force.

Not only were you contributing to the community as far as you know, sponsorships, but you were there for information and outreach programs, which was very good and this office in the last couple years have shown a great presence here on the island and the contributions you made to this island.

In exchange, I continue to work with Taiwan too, with your technology. Taiwan is one of the forefronts on waste to energy to, recycling, reusing, and, a lot of that information is brought to Guam and we go to Taiwan to seek it. So, we're a small island and, there's not going to be much area left over for our dumping that we're going to have to find a way to deal with our waste.

So Taiwan has been a great advocate to assist us in that, and I continue to work with Taiwan and in exchange, whatever we can do to support you as well I'm here to support it. Thank you so much.

Chi-Chang "Vincent" Lu - Deputy Director TECO in Guam: Thank you so much. Yes. I think we will strengthen it further. Yes. And the cooperation between, exchanges between Taiwan and Guam and our Director General Paul Chen will considered it because of lasting efforts, yes, regarding, the, to, to, to strengthen, the bilateral relations between Taiwan and Guam of, since, our office reopened two and a half, two and a half years ago, and right now we are doing this, we, we'll continue to make efforts to cooperate with, with you, with the Guam Legislatures and that we are going to do this. Yes. Because your suggestions are really constructive and the with the proposal. I, I, I will, I will talk about it with our Director General Paul Chen and maybe our, he will, meet with you in the future and we, this is a very good idea. Thank you so much. Yes.

Vice Speaker Tina Muña Barnes, Chairperson: Thank you, Deputy Director. Senator Brown?

Senator Joanne M. Brown: Thank you very much, Madam Chair. And I also, in co-sponsoring this with you, support, the resolution. Taiwan definitely, and the

region has very, very much a good friend and a good partner to the Pacific and I think that's something we all need to value, considering the world situation and what we're dealing with with our other neighbors that are not as friendly and not as progressive and, and are more aggressive in their approach.

And so certainly the technology, the support, certainly on Guam as Senator Telo had mentioned, the return to have your office back here in your presence, engagement and the, and the direct contributions that Taiwan has made to our community. Certainly during the pandemic, Taiwan has taken very much a lead on how to address the safety and health issues and you've always, as a country, have always extended out your support to others in the world. And I think that that says a lot. It's not just what you need to do internally within your country to grow and develop, but how you extend and expand that help, in the world and also particularly in the Pacific region where we are all neighbors.

So, we continue to support your efforts and thank you for your partnership and continued presence. We have bigger challenges in the world out there. We have a lot to gain in, in keeping united and working together to support what we value in our quality of life and our freedoms. So, we, we look forward to continued partnership with Taiwan. And while we recognize certainly the international, national situations, of course, with the United the good thing is we have continued that partnership and we want to continue to work with you. So, with that Madam Chair, thank you very much and thank you for your testimony this morning.

Vice Speaker Tina Muña Barnes, Chairperson: You're very welcome, Senator Brown. And if there's no one else in the audience to present oral testimony, I will conclude that Resolution No. 30-37 (COR) is publicly heard. Thank you very, very much. Thank you, Deputy Director.

Chi-Chang "Vincent" Lu - Deputy Director TECO in Guam: Thank you Vice Speaker.

1 **BE IT RESOLVED BY *I MINA'TRENTAI SIETTE NA LIHESLATURAN***
2 ***GUÁHAN*:**

3 **WHEREAS**, One Hundred and Eleven years ago on October 10, 1911, the
4 Republic of China (Taiwan) was founded. The United States of America and the
5 Republic of China (Taiwan) have been friends and allies for many years. Throughout
6 this time the ties of friendship and the commercial interests of the United States of
7 America and the Republic of China (Taiwan) have developed into a strong partnership;
8 and

1 **WHEREAS**, the freedom and democracy enjoyed by the people of the Republic
2 of China (Taiwan) are clearly demonstrated in the progress and growth of the economy
3 of this great country. In furthering its commitment to freedom and democracy, Taiwan
4 continues to seek representation and meaningful participation in international
5 organizations; and

6 **WHEREAS**, in line with the Taiwan Relations Act of 1979, Asia Reassurance
7 Initiative Act of 2018, Taiwan Travel Act of 2018, and the Taiwan Allies International
8 Protection and Enhancement Initiative (TAIPEI) Act of 2019 Guam intends to continue
9 to maintain relationships with one of our closest democratic countries in the Pacific;
10 and

11 **WHEREAS**, since April 2008, *I Liheslaturan Guåhan* adopted Legislative
12 Resolutions commending the efforts of the Republic of China (Taiwan) to promote
13 World Health and had endorsed Taiwan’s observer status in the World Health
14 Assembly. The people of Guam maintained a special Sister-City relationship with the
15 people of Taipei City since 1973, and believe that good health is important to every
16 citizen of the world and believe that access to the highest standard of health information
17 and services is necessary to improve the public health; and

18 **WHEREAS**, the preamble of the World Health Organization (WHO)
19 Constitution states that “the enjoyment of the highest attainable standard of health is
20 one of the fundamental rights of every human being without distinction of race, religion,
21 political belief, economic or social condition.” Taiwan’s twenty-three million five
22 hundred thousand (23,500,000) people wish to attend the WHA as an observer; and
23 have a population that is greater than three-fourths of member states already admitted
24 into the WHO. Because health and disease have no borders, it is in the best interest of
25 the human condition that Taiwan be afforded observership in the WHO in order to
26 benefit from information regarding the prevention, monitoring and cure of epidemic

1 diseases, prevention of terrorist bio-chemical attacks, and discussions of global health
2 policies; and

3 **WHEREAS**, Taiwan’s achievement in the field of health is substantial, including
4 one of the highest life expectancy levels in Asia; maternal and infant mortality rates
5 comparable to those of western countries; the eradication of such infectious diseases as
6 cholera, smallpox, and the plague; and being the first nation to eradicate polio and
7 provide children with Hepatitis B vaccinations; and

8 **WHEREAS**, Direct and unobstructed participation in international health
9 cooperation forums and programs is beneficial for all parts of the world, especially with
10 today’s greater potential for cross-border spread of various infectious diseases such as
11 human immunodeficiency virus (HIV), tuberculosis, malaria, and COVID-19; and

12 **WHEREAS**, the World Health Assembly has allowed observers to participate in
13 activities of the organization, including the Palestine Liberation Organization in 1974,
14 the Order of Malta, and the Holy See in the early 1950s. The United States, in the 1994
15 Taiwan Policy Review, declared its intention to support Taiwan’s participation in
16 appropriate international organizations. U.S. Public Law 106-137 required the Secretary
17 of State to submit a report to the congress on efforts by the executive branch to support
18 Taiwan’s participation in international organizations, in particular the WHO; and

19 **WHEREAS**, During the G7 Foreign and Development Minister’s Meeting in
20 May 2021, the G7 countries comprising of Canada, France, Germany, Italy, Japan, the
21 United Kingdom, and the United States, supported the inclusion of Taiwan at the World
22 Health Assembly through a joint communique; and

23 **WHEREAS**, the Republic of China (Taiwan) continues to demonstrate
24 incredible assistance to Guam’s health system. On March 30, 2022, the JAG TeleCare
25 remote health monitoring platform was donated to the Guam Memorial Hospital
26 Authority to strengthen Guam’s telehealth services and expand our network of
27 healthcare coverage for the people of Guam; and

1 **WHEREAS**, additionally, knowing that the stray animal population in Guam
2 continues to be a serious situation to our community, a team from the Department of
3 Veterinary Medicine of Taiwan’s National Chung Hsing University volunteered their
4 time in August 2022 to a spay and neuter program. The program committed to spay or
5 neuter four hundred (400) animals. The team also lent their expertise, giving lectures at
6 the University of Guam pertaining to responsible pet care and ownership; and

7 **WHEREAS**, during the pandemic, 200,000 masks, 900 Pandemic Readiness
8 Kits, and four full-body temperature scanners were secured with the assistance of the
9 Taipei Economic and Cultural Office in Guam (TECO). Furthermore, in January of
10 2021, with the help of TECO in Guam and the Ministry of Foreign Affairs, flights were
11 chartered with China Airlines as a joint humanitarian and medical mission for about 50
12 passengers each flight. This endeavor was especially beneficial to Guam residents
13 seeking medical treatment off island but have been unable to do so because of the
14 COVID-19 health crisis and canceled direct flights; and

15 **WHEREAS**, prior to the pandemic, patients in Guam received life-changing
16 specialized care from hospitals in Taiwan. The China Medical University Hospital in
17 Taichung and Yuan’s General Hospital in Kaohsiung are just a few of several hospitals
18 that care for Guam patients. Additionally, the Guam Memorial Hospital maintains a
19 referral hospital relationship with Taiwan Adventist Hospital in Taipei with a
20 memorandum of understanding signed in January 2020. Taiwan Adventist Hospital
21 continues to be supportive of the Guam Memorial Hospital donating personal protective
22 equipment, including face masks and face shields to the GMH in April 2021. Moreover,
23 Taiwan sends physicians to teach the physicians in Guam and to offer support to our
24 medical community; and

25 **WHEREAS**, During the House Foreign Affairs Committee Hearing on the Biden
26 Administration Foreign Policy Priorities in March 2021, Secretary of State Antony
27 Blinken testified his commitment to work on including Taiwan at international

1 conferences due to their immense contributions and invaluable technical expertise
2 during the COVID-19 pandemic. Moreover, President Biden restated the United States
3 support of Taiwan in the interim National Security Strategic Guidance issued by the
4 White House on March 2021; and

5 **WHEREAS**, Guam further intends to reaffirm and deepen our Sister City
6 relationship with Taipei, Taoyuan, and Taichung by supporting efforts to grant Taiwan
7 participation at international organizations including the International Civil Aviation
8 Organization (ICAO), United Nation Framework Convention on Climate Change
9 (UNFCCC), and International Criminal Police Organization (INTERPOL). Taiwan’s
10 participation will promote; now, therefore be it

11 **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan*, on behalf of
12 the people of Guam, does hereby express its full support for the government and the
13 people of Taiwan, that they deserve the same level of public health as citizens of every
14 nation on earth, and that we support them in their efforts to achieve its objective to
15 become an observer of the World Health Assembly to be held WHO; and be it further

16 **RESOLVED**, that *I Mina'trentai Siette Na Liheslaturan Guåhan*, on behalf of
17 the people of Guam, does hereby support granting Taiwan observer status at
18 intergovernmental organizations including the International Civil Aviation
19 Organization (ICAO), United Nation Framework Convention on Climate Change
