



AN ACT TO *AMEND* SECTION 2 OF PUBLIC LAW 36-139.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 2 of Public Law 36-139 is hereby *amended* to read:

3 New Subsection (a)(8) is hereby *added* to §51111 of Article 1, Chapter
4 51, Title 10, Guam Code Annotated, to read as follows:

5 **“§ 51111. Prohibited Hazardous Waste Activities.**

6 (8) open burn hazardous waste.”
