Håfa Adai Madame Speaker,

Repealing inactive, duplicative, short-term, or single-purpose boards and commissions is a significant step toward reducing the size of government and improving government efficiency. In furtherance of this goal, Bill No. 65-37 (COR) seeks to abolish the inactive Guam Multi-Purpose Community Stadium Complex Commission.

At present, nearly 1,000 positions exist among over 100 government boards, commissions, and councils. In the Transition Report I submitted to the 35th Guam Legislature, the 2018 Transition Advisory Committee noted that many government boards and commissions lacked quorum or qualified individuals willing to serve. For this reason, the Transition Advisory Committee recommended that the Legislature abolish unnecessary and inactive boards, including the Guam Multi-Purpose Community Stadium Complex Commission, which has never convened and has no appointed or confirmed members.

Lieutenant Governor Josh Tenorio and I commend Senator Will Parkinson for his efforts in introducing legislation to abolish inactive, duplicative, short-term, or single-purpose boards and commissions, which will effectively reduce bureaucracy, save taxpayer dollars, and allow our agencies to focus on their active statutory mandates.


